

Rating Action: Aguascalientes, Municipality of

Moody's retiró las calificaciones de los certificados bursátiles por 100 millones MN del Municipio de Aguascalientes

Mexico City, March 03, 2009 -- Moody's retiró las calificaciones Aaa.mx (escala nacional de México) y Baa1 (escala global, moneda local) asignadas a los certificados bursátiles por 100 millones MN del Municipio de Aguascalientes, los cuales se pagaban mediante un fideicomiso usando las participaciones federales que le corresponden a la entidad. Moody's ha retirado estas calificaciones debido a que el municipio prepagó la totalidad de los certificados por voluntad propia y los certificados bursátiles no continúan vigentes. La última acción de calificación relativa a los certificados fue tomada en noviembre de 2005 cuando se asignaron las calificaciones sobre ellos.
